



# STATEWIDE WARRANT ROUND-UP

**A Warrant is Pending for Your Arrest - Act Now to Avoid Going to Jail**

**Beginning Saturday, March 5, 2011**, over 240 law enforcement agencies across Texas will be concentrating their efforts to arrest you on warrants.

You may be arrested at your home, place of business, or anywhere that you may be found. Your car may be impounded if you are stopped and arrested while driving incurring tow and storage charges.

**PAY YOUR ASSESSED FINES IMMEDIATELY.**

## **TO AVOID THE EMBARRASSMENT AND EXPENSE OF ARREST, YOU MAY:**

1. PAY THE FULL FINE AMOUNT WITH A CREDIT CARD ONLINE AT [www.cityofpalestinetx.com](http://www.cityofpalestinetx.com) or by CALLING (903) 731-8433 or (903) 731-8466; Visa, MasterCard or Discover accepted.
2. PAY THE FULL FINE AMOUNT by enclosing this notice in the envelope provided with your full fine payment, name, driver's license number and or citation number. Fines may be paid by A CASHIER'S CHECK or MONEY ORDER made payable to the **CITY OF PALESTINE**. Or, by phone with credit card at the numbers listed above. \*IF YOU PAY BY MAIL, YOUR WARRANT(S) WILL REMAIN IN EFFECT AND YOU REMAIN SUBJECT TO ARREST UNTIL THE COURT RECEIVES AND POSTS YOUR PAYMENT.
3. PAY THE FULL FINE AMOUNT IN PERSON. Fines may be paid in person with cash, cashier's check, money order, or one of three major credit cards.
4. PAY THE FULL FINE AMOUNT AT THE DROP BOX located in the water department drive thru window. This notice must accompany a cashier's check or money order (no cash please) along with your name, driver's license number and or citation number.
5. PLEAD NOT GUILTY IF YOUR CASE IS UNADJUDICATED AT THE COURT. You will be required to post a bond and you will be notified of your trial date when set.


