# D. Consideration and Possible Action Concerning:

Motion to approve the February 2017 Financial Report was made by Paul Morris and seconded by Linda Dickens, with unanimous vote to approve financial report.

## E. Briefing and Discussion Concerning:

Economic Development Report provided by Tom Manskey.

- Go Texan Retirement Application was submitted to Texas Department of Agriculture in Austin.
- The design for PEDC new website is 75% complete. The picture appointments for Board members are needed on afternoon hours on March 22<sup>nd</sup> or March 23<sup>rd</sup> morning hours.
- Terry Johnson is attending Leadership Palestine for 2017 representation from economic development.
- A developer is showing pad sites to potential tenants near the Palestine Mall.
- JC Penney will name stores to be closed in 2017 on Monday, March 20th.
- Chili's is scheduled to open by the second week in May 2017.
- Taco Casa should open by June 2017.
- The residential development group working on a project near Willow Creek Business Park is expected to request an extension on their land contract. They are interested in local incentives from City of Palestine, i.e. TIRZ or TIF.
- The house proposed for redevelopment on Highway 79 across from Sonic has been sold to a private citizen.

Main Street Report provided by Greg Laudadio.

Tourism Report provided by Mary Raum.

Mary discussed the upcoming month and previous few weeks focus on Dogwood Trail activities, and requested the traffic counter be placed at Davey Dogwood Park early due to the early blooming season. As of Monday, March 13, 2017, a total of 1,257 cards had passed through the park, but the counter was malfunctioning since Tuesday AM. Park staff are working to correct the issue. Mary also provided a recap of the social media reach for the past 28 days, outlined the article where Palestine was featured in the March/April issue, and covered the response for the Day Tripper Episode.
