E. Briefing and Discussion Concerning:

Economic Development Report -

PEDC completed their website soft launch 05-24-17.

We have two additional staff members, Victoria Minton from the Convention Center, working directly with Mary Raum. Danielle Schultz works directly with Mary Raum for city events and Greg Laudadio for Farmer's Market.

Chili's Grand Opening date was 5/22/17.

Our next PEDC Board Meeting will be held June 15th, and there will be a special joint meeting with PEDC Board & Palestine City Council on June 22 at 5:30pm.

Main Street Report -

Approximately 75 attendees were present for our first annual Imagine the Possibilities Tour. This meeting promoted all of our available for lease or sale downtown properties in the Main Street area. Visit downtowntx.org for an online building inventory and click on Palestine for the Palestine downtown area list.

San Angelo, Texas is the location for 2017 Main Street training on June 14, 15, & 16.

KSA will enter discussions with Palestine City Council sometime before Phase II can be approved by City Council. A meeting with Francois should take place sometime in the month of June 2017 to answer questions the council has for Phase II and the Main Street study project.

Tourism Report-

March 2017 hotel sales are up 26.9% from one year ago Visitor Center Traffic is up 21.3% from one year ago

F. Consideration and Possible Action Concerning:

Community Development Grant – The PEDC Board voted four projects through, that now move to a vote at City Council. Alan Herrington made the first motion, and second motion made by Linda Dickens with unanimous approval to provide the following Community Development Grants. The vote now moves to the City Council.

\$25,000 towards re-roof and painting exterior of the Palestine Depot at Texas State Railroad

\$11.500 Complex lighting at the Palestine YMCA Soccer field

\$9,500 towards the Palestine Tomorrow Sculpture Park for granite panels, sidewalk, signage & landscaping

\$4,000 to Palestine Youth Athletics for commercial vent hood & fire suppression system at athletic complex concession area

G. Consideration and Possible Action Concerning:

Facade Improvement Grant Program – Owner Jerry Hatton, from the former Beauty College building, needs to provide bid information for work other than the building roof so that his building can be considered for the 2017 FIP. Jacob Morris and Greg Laudadio have scheduled a June meeting with Timothy Triplett Main Street building owner in order to tour the building in its current condition. We have two possible requestors for FIP grant money for 2017.

H. Consideration and Possible Action Concerning:

Broker/Realtor Policy for land sales in Willow Creek Business Park. In a future meeting, Economic Development Director will bring consideration to vote for a 3% realtor fee to be split between all realtors involved bringing a closed real estate deal to Willow Creek Business Park.

I. Consideration and Possible Action Concerning:

Easement request for access to 48.958 acres more or less, out of William S. McDonald Survey, A-43, Anderson County, Texas. Economic Development Director will address the PEDC Board concerns at our regular scheduled June 2017 meeting. There will be a time limit and date on any easement granted. This easement would be located on Live Oak, which is the second drive past Comfort Suites Hotel.

J. Consideration and Possible Action Concerning:

Proposed engagement letter for PEDC legal services from the Nichols Firm, PLLC. Larry Weber made motion, and seconded by Alan Herrington, to accept the engagement letter from the Nichols Firm from Houston, TX. The vote was unanimous.

K. Consideration and Possible Action Concerning:

Possible future acceptance of commercial and/or residential properties that have been placed into trust by the taxing entities in Palestine and Anderson County. Economic Development Director reported the City of Palestine has property in trust, and the city can give property to PEDC for marketing purposes on behalf of the city.
