## BUSINESS ALARM PERMIT APPLICATION

#### SERVICE FEES FOR FALSE ALARMS

4 to 9 False Alarms within 12 months: \$100.00 per Police/Fire Dept. response

More than 10 False Alarms within 12 months: \$150.00 per Police/Fire Dept. response

*False alarm* means an alarm notification when police personnel responding within 30 minutes of the alarm notification find no evidence of an attempted or actual unauthorized intrusion, burglary, robbery, theft, hostage taking or fire. False alarm does not include any activation of an alarm system:

- (1) Caused by tornadoes, lightning, earthquakes, thunder, gale-force or higher winds, or other weather-related phenomena; or
- (2) To which the response by emergency personnel is canceled by either the alarm system user or his authorized agent prior to the arrival of responding personnel at the alarm site.

#### PAYMENT INFORMATION AND PERMIT DURATION

Upon completion of the application, you can return the application along with a check or money order in the amount of **\$40.00** payable to the City of Palestine by one of the following:

No application will be processed without the application fee. Business alarm permits, once approved are valid for one calendar year beginning on January 1 and expiring on December 31. A copy of the alarm permit will be sent to the email address provided on the application. If none is provided, a copy will be mailed to the permit holder.
