BREAKDOWN

WATER CHARGES

Water Rate Consists of:

- Base charge up to 2,000 gal- ¾ to 1" Residential/Commercial is \$7.25
- Sprinkler Meter ¾ to 1" \$11.34
- Base charge increases with meter size.

SEWER SURCHARGE

Charge designed to recover increased debt service & operating costs for EPA-mandated improvements or other sewer infrastructure projects.

STREET/ DRAINAGE MAINTENANCE

Charge for maintenance & cosmetic upkeep of the streets / drainage system.

TRASH CHARGE

Commercial
Based on size of trash cart

Residential
Charge for trash service is \$14.85 for 1 trash cart. Extra trash carts can be added and will be charged \$5/mo. per cart.

SALES TAX

Sales Tax is 8.25% of the Trash Charge.

METER REPLACEMENT CHARGES

\$6.30 per month is charged to all residential and commercial accounts. The fee pays for the replacement of old water meters with new ones.

PENALTY

A penalty is charged on past due bills. The penalty is 3% of the past due balance, excluding taxes if paid after due date.
